**Additions needed in commercial districts**. There was a clear consensus that the respondents wish to have more restaurants [>80%] and more retail venues [>70%]. The types of restaurants desired varied greatly from child friendly to pub type bars. There was some enthusiasm for more green space [<30%] in the commercial districts.

How to enhance a stronger sense of community among Winnetka residents. A majority of respondents [>50%] want more Village sponsored community events, i. e. First Thursdays and encouraging restaurants & shops to have certain nights when thy have extended hours. Slightly less than half want to see an on line community calendar built and maintained. There was little enthusiasm expressed for bringing back "welcome baskets" to new residents; nor was there enthusiasm expressed for the Caucus to sponsor open houses with Village officials.

One Winnetka proposed development. Respondents had a mixed perception of the One Winnetka development of the blocks on Lincoln Avenue and Elm Street before its most recent modification: 35% responded that it should be approved in its then current form, 39% responding that it should be approved only if there are changes, and 27% responded they do not know enough to respond.

**Strand proposal for the management of stormwater**. It was clear from the response to this question on the Stand proposal that many of the Village residents [41%] wish to have more information in order to have an informed response to this proposal with 22% responding that they wish to have Stand proposal accepted in its current form.

# The following is 2016 Village Platform distilled from the above summary of the survey:

- 1. The Village in concert with the Downtown Master Plan should encourage more restaurants and retail venues to open in the Village.
- 2. In order to enhance a stronger sense of community, Winnetka residents want more Village sponsored events, i.e. First Thursdays and encourage restaurants and shops to have extended hours on specific nights.
- 3. The Village needs to provide the residents with more detailed information on the Strand proposal for the management of stormwater.
